Re: The Ellen Gordon Allen Memorial Garden

The Ellen Gordon Allen Memorial Garden at the U. S. National Arboretum in Washington, D. C. was as a gift to the American people from Chapter No. 1 and the many friends of Ikebana International around the world. It is a living tribute to Mrs. Allen, the Founder of Ikebana International and a Washington, D.C. native.

Following Mrs. Allen's death in 1962, Chapter No. 1 formed the Ellen Gordon Allen Memorial Committee and established the Ellen Gordon Allen Memorial Fund. The Committee set about finding a suitable memorial for Mrs. Allen. The U. S. National Arboretum was an early focus of the Committee due to an already established relationship with the Arboretum for hosting the Chapter's ikebana exhibitions. In 1977, Chapter No. 1 purchased the Mary Cokely Wood Collection of rare books on Ikebana and presented it to the National Agricultural Library (the parent agency of the Arboretum) in memory of Mrs. Allen. There followed other attempts to create a memorial, including the possible donation of "a moon bridge" to be located in a future building phase of the Bonsai Museum. This phase did not take place at the time, due to a lack of funds.

In December 1981, an alternate plan was offered - the installation of a memorial garden at the newly established main entrance to the bonsai collection. This was approved by the Chapter No. 1 Board in February 1982 and a donation of \$19,600 from the Chapter and the Ellen Gordon Allen Memorial Fund was made through "the Friends of the National Arboretum" (FONA). This timing coincided with the 25th Anniversary of Ikebana International and the Washington, D. C. Chapter. The garden was designed by Thomas Wirth, Sasaki Association, Watertown, MA; and constructed by Osamu Shimizu, Shimizu Landscape Corporation, Glen Echo, MD. A "ground breaking" ceremony took place on June 2, 1982 and the garden was dedicated on June 9, 1983. There is a bronze plaque located in the garden which reads: "This Garden Is Dedicated to the Memory of ELLEN GORDON ALLEN Founder Ikebana International by Washington, D.C. Chapter No. 1 and Friends Around the World".

The donations to the Ellen Gordon Allen Fund came from many sources including: Royalties from Mrs. Allen's book "Ikebana in a Nutshell"; sale of Mrs. Allen's containers and other artifacts; proceeds from the 7th North American Regional Conference; donations from Ikebana International, Chapter No. 1 members and other Chapters around the world; special appeals to the major schools of Ikebana, the Embassy of Japan, and other cultural organizations. An ongoing source of funds are the donations made in memory of former Chapter No. 1 members.

Since its establishment, Chapter No. 1 has continued to provide funds for the improvement and maintenance of the garden. There is mention in the archives of an expansion plan (by Osamu Shimizu) in 1984/85. Through 2001, the donations were made through FONA, including \$3000 that year. However, due to a lack of accountability, the Board voted in December 2001 to establish an Ellen Gordon Allen Fund, under the control of the Chapter, to administer the money. Donations for the Ellen Gordon Allen Memorial Garden are now made directly to the Arboretum. Notably, \$4000 was donated in 2011 to plant the Prunus "First Lady" cherry tree and other plantings "to enhance the Japanese feel of the area"; and in 2013 funding to plant a Weeping Maple tree in the stroll garden.

For the past year the U.S. National Arboretum has undergone a major renovation so projects have been delayed or on hold.

Although it has been almost a year since Mrs. Fujisaki left, we are now able to dedicate this Weeping Maple in her honor.

During the 4 years that Mrs. Fujisaki was the Japanese First Lady to the United States, we admired her dedication to Ikebana, Japan -American relations and her strong leadership following the tragic 3/11 earthquake and tsunami in Japan.

As Ambassador Fujisaki and his wife prepared to leave Washington DC last year the Chapter No. 1 Board voted to dedicate a tree at the Arboretum in her honor.

Sachiko Furlan and I worked on this project and Sachiko worked tirelessly with the Arboretum staff to identify a tree that would represent our appreciation. A mature, elegant tree located in the middle of the Japanese Stroll Garden here in the Arboretum is the perfect representation. This Weeping Maple has been selected to honor Mrs. Fujisaki and the enduring friendship we have with Japan and the culture that we admire, study and appreciate.

Like the Japanese, this Weeping Maple gracefully bows, but is strong and resilient. This lovely maple will continue to grow and show its grace and the beautiful color of changing seasons to visitors from all over the world--- long into the future.

We are honored to dedicate this elegant Weeping Maple tree representing the strong bond of Japan-American friendship and the beauty of nature to Mrs. Fujisaki.

Dear Dr. Hefferan,

Ikebana International and the U. S. Arboretum have had many years of collaboration, especially with annual exhibitions which were originally held in the auditorium of the administration building before the National Bonsai and Penjing Museum was built. Ikebana International financially supported the Ellen Gordon Allen (founder of Ikebana International) entrance garden to the bonsai area, and has given monies for other smaller projects.

We have been in discussion with Carole Bordelon, Kathleen Emerson-Dell, and Dr. Pooler about where we can financially assist in adding to and refurbishing the area which is near the Ellen Gordon Allen Garden. We initially felt that planting a cherry tree to commemorate the 100^{th} year anniversary of Japan's gift of cherry trees to the United States would be a fitting project. In addition, we wanted to know if there were other needs that would enhance that area. The following are items that they felt would enhance the area with our financial assistance:

Plant Prunus 'First Lady' in the grassy spot at the top of the ramp next to the Acer Remove the Deutzia, Jasminum parkeri, and Corylopsis pauciflora

Replant with more Ophiopogon to establish better groundcover at base of shrubs

Prune Glen Dale Azaleas after flowering to reduce them in size somewhat and begin to shear them in

Japanese karikoma style to give the bed a more Japanese feel to the area.

Removal of the Acer at the top of the steps up to the terrace, to be replaced with a specimen Evergreen shrub such as Chamaecyparis obtusa (to echo the ones on the other side of the steps).

Installation of a short stone path from the paved entrance plaza to the grassy area on the right starting at the base of the ramp in a Japanese style of mixed cut and natural stones.

Ikebana International has voted to donate \$4000.00 for the completion of the above project which we would like to have dedicated during our scheduled exhibition next spring. It would

also be much appreciated to keep us updated on the progress of the project as many members are frequently at the Arboretum and would enjoy watching the project.

Accordingly, enclosed is a check in the amount of \$4000.00 for the above project and we look forward to many more areas of collaboration.



The Ellen Gordon Allen memorial Garden at the U.S. National Arboretum in Washington, D.C. was dedicated on June 9, 1983 as a gift to the American people by Chapter No. 1 and the many friends of Ikebana International around the world. This elegant and stately garden forms the entrance to the National Arboretum's extensive Bonsai Collection. The Garden is a fitting and lasting tribute to a great and gracious lady whose foresight, dedication and leadership has bequeathed to so many an appreciation of the charm and beauty of Ikebana. The Garden consists of a large stone terrace with broad steps and is graced by a dramatic reclining Pinus Thumbergii the trunk of which has been wrapped with rope and a supporting brace. Also in the space are other plants of Japanese origin such as Acer, Chamaecyparis, Deutzia, Ilex, Lagerstroemia and Prunus. The planting also contains ground covers and perennials. The entire garden is flanked by 30 foot Cryptomeria Japonica trees. A stone bench provides a pleasant resting place for visitors to enjoy this lovely space attributed to our Founder.

Dear Ms. Wilson,

This is to confirm the recent action by our board regarding the funds in the Ellen Gordon Allen Memorial Fund which is held by FONA. Elizabeth Phibbs presented the needs of the garden and the items most needed by the Ellen Gordon Allen Garden. The board voted to accept the proposal of \$750-\$1000 to be used for plantings for the garden and the balance to be used for a design of an irrigation system for the garden. It is our understanding that the Arboretum is prepared to fund the balance of the irrigation system and that it will be installed in a timely way. The concern was that a design would be done and installation would not be completed promptly which could render the possibility of the design not being implemented.

It is our understanding that there is \$3307.00 in the aforementioned fund and that these projects would close the fund.

We thank Elizabeth Phibbs for making this presentation and for the time and efforts she has devoted to the plans.



Benefit Raises Funds For Columns Project

The National Columns Project at the U.S. Arboretum was the beneficiary of a fund-raising event held Wednesday, November 29, 1984. The design, created by noted landscape architect Russell Page, will accommodate 24 limestone columns designed by Benjamin Latrobe which originally graced the U.S. Capitol's East Front and which were removed during its renovation in 1962.

Benefit chair was Cecil Carusi; honorary co-chair was Mrs. George (Ethel) Garrett, longtime Washington philanthropic leader who was almost single-handedly responsible for having the columns removed from storage on the Anacostia River's banks and removed to the Arboretum where one is on display near the Education Building.



The benefit dinner featured a retrospective collection of fashions by Hanae Mori, the Japanese haute couture designer, and jewelry lent by the firm Harry Winston, Inc. Held at the Madison Hotel in Washington, D.C., the event drew 230 guests.

- It authorized the Arboretum Director to secure preliminary renderings and cost estimates for the National Columns Project (Latrobe's Capitol columns).
- The Board authorized a reception for FONA members on March 13, during the 1985 Washington Flower &Garden Show. The first 150 FONA members who make reservations to attend will receive free show tickets as a membership benefit (at least a \$5.00 value). More information about this event will appear in future mailings and in the March FONA NEWS.

- It agreed to establish accounts for funds given and spent on the National Youth Garden Project.

He is now retired from the Department of Agriculture, where he spent 34 years, and is a specialist in using plant materials, including ground covers and cold-hardy ornamentals, for erosion control and environmental enhancement.

FRIENDSHIP THROUGH FLOWERS

THE ELLEN GORDON ALLEN MEMORIAL GARDEN located at the U.S. National Arboretum, Washington, DC

Friendship through flowers is a universal aspect of all who admire plants and the environments in which they grow. The most cherished of these plants are moved and become a part of a created landscape out-of-doors or as an ornament/living design in our interiors. We thus treasure the plants from the wild landscape, learn how to propagate and grow them in a wide range of environments, and honor them with places of prominence in our living spaces.

The American Gardens are particularly indebited to plants whose origins can be traced to Asia. We estimate that 38 percent of the trees and 28 percent of the shrubs in our gardens are from Japan, Korea, and China. These plants thrive in our garden spaces. Along with the plants, have come many traditions of design, propagation, and culture. We do not expect that they will grow unattended. The plants of Asian origin can be clipped, trained, and formed to create landscapes in a miniature form that captures all the grandeur of the unbounded natural landscapes.

The U.S. National Arboretum has been the beneficiary of the Nippon Bonsai Association of Japan, who presented 53 magnificent bonsai to the people of the U.S. as their gift for the Bicentennial. The collection included 3 bonsai from the Imperial Family and 3 from former Prime Ministers. The arboretum then constructed a Japanese Garden and Bonsai Pavilion to house the Collection and to expand the experiences of visitors.

The first phase of the expansion of the Bonsai Complex was funded by Ikebana International, Washington, D.C. Chapter No. 1 in honor of their founder— Ellen Gordon Allen. The garden was designed by Mr. Thomas Wirth, Sasaki Associates, Watertown, Massachusetts and was constructed by Mr. Osamu Shimizu, Shimizu Landscape Corporation, Glen Echo, Maryland. Mrs. Herbert O. Jones, President of the Washington, D.C. Chapter of Ikebana International, Mrs. Paul Godbey, Chairman of the Ellen Gordon Allen Memorial Committee, and members of the Washington Chapter dedicated their garden on June 9, 1983, in cooperation with the Friends of the U.S. National Arboretum.

The elegant and stately garden is attached by a series of steps to either the terrace of the Administration Building or Meadow Road. We have provided a ramp for the handicapped to enter the garden space and granite benches and ledges to allow visitors to rest and savor the garden. The largest plant in the space is a reclining Pinus thunbergii. (Drawing plant list) It's trunk has been wrapped with rope to add to the design and a brace has been added to support it. Planted in the space are other plants of Japanese origin such as Acer, Chamaecyparis, Deutzia, Ilex, Lagerstroemia, and Prunus. The Rhododendrons have been selected not only for their spring flower color but also for their contrasting fall foliage colors. The planting also contains groups covers such as Ophiopogon and Ternstroemia, and perennials such as Aster Pespedeza and Lilium. The entire garden is flanked by 30 foot trees of Cryptomeria japonica. Most of the trees and shrubs in the garden show up again in the pavilion as a bonsai, with some of the plants as old as 350 years.

The National Bonsai Foundation has now been formed to help complete the Bonsai Complex by adding a U.S. garden and exhibition area, and a Chinese garden and plant exhibit. The Ellen Gordon Allen entrance thus states again the ageless appreciation that we have for "Friendship through Flowers".

Report of the Ellen Gordon Allen Memorial Committee

Since 1972, Washington, D. C. Chapter No. 1, Inc., has been planning an appropriate memorial for our founder, Ellen Gordon Allen, in the Nation's Capital.

During the year 1977-78, the committee had board approval to investigate the possibility of placing a moon bridge at the United States National Arboretum. In June, 1977, an appropriate spot for a moon bridge in Phase III of the bonsai collection was found, but to our disappointment. Phase III was deactivated because of lack of funds.

As you may remember, this chapter did donate a collection of rare books on Japanese flower arranging to the United States National Arboretum which action we felt was in consonance with our decision to establish a moon bridge at the same institution at a later date.

Since this year (1982) is the 25th anniversary of the founding of Ikebana International, the memorial committee would like very much to see this memorial completed.

At a recent meeting on December 10, 1981, with Dr. Cathey, Director of the Arboretum and two other staff members, we were told that our idea of a memorial is still well received but that Phase III may not be reactivated for many years.

An alternate, feasible plan was offered - the establishment of a memorial garden, with suitable plaque, at the newly established main entrance to the bonsai collection. This entrance will be opposite the herb garden entrance and will continue on through the presently situated cryptomaria trees. The architect for the arboretum will create detailed plans for the memorial garden which will be approximately 30' x 18'. The garden will have two stone lanterns, several benches, stepping stones and proper footing. The Arboretum will furnish the plants and shrubs.

The memorial committee has unanimously approved the concept of a memorial garden which appears to be within the financial capability of this chapter, and on February 2, 1982, the board also approved the concept.

To charter members, individual members of Chapter No. 1, friends and schools in the Washington, D. C. area, if you have not contributed to the Ellen Gordon Allen Memorial, now is the time. You may send your contribution by May 11, 1982 to:

Helen W. Godbey (Mrs. Paul), Chairman 1111 Villamay Boulevard Alexandria, Virginia 22307 During the year 1977-78, the committee formulated plans to have a moon bridge placed at the National Arboretum in connection with the bonsai collection with a suitable memorial plague.

Betty Taylor was chosen as representative from Ikebana International to contact the authorities at the National Arboretum to discuss the memorial with them and to investigate the cost of the bridge. In June, 1977, Betty Taylor, Marion Scott and I met with Dr. Creech, Mr. March, and Mr. Kinoshita, Architect for the Arboretum. Following that meeting, Mr. Kinoshita found an appropriate spot for a moon bridge in Phase III of the bonsai collection, but to date no price has been mentioned. Another meeting is planned.

Also during this year, the I. I. board authorized this committee to purchase a group of rare books on Ikebana which were collected by Mary Cokely Wood of Ann Arbor, Michigan, and offered for sale by Mr. Lawrence E. Gichner, 3405 Woodley Road N. W., Washington, D. C. 20016. On November 16, 1977, this committee met with three representatives of the Library of Congress at Mr. Gichner's premises to review the books and to establish their authenticity. The Library of Congress experts assured us that they were authentic and were not over priced. Accordingly, these rare books were acquired with the idea of contributing or lending them to some institution in memory of our Founder. At this time, three institutions are interested in acquiring them - The Library of Congress, University of Maryland, and National Agricultural Library at Beltsville, Maryland. Before we contribute or lend these rare books to an institution, the entire membership of Ikebana International will be invited to view them at a special showing at Army Navy Country Club on June 13, before the installation luncheon.

Some additional information is required from the Arboretum concerning the bridge, and from some of the institutions interested in acquiring the books. When this is received, a recommendation on final action will be made to the board by this committee.

It has been a pleasure to serve with Betty Taylor, President, and all of the executive board for the year 1977-78.



The Ellen Gordon Allen Memorial Garden at the U.S. National Arboretum, Washington, D.C.

by Henry M. Cathey, Director

Our thanks to Henry Cathey, the director of the U.S. National Arboretum in Washington, D.C. for sending us this detailed account of the garden in the U.S. Arboretum named in honor of our founder, Ellen Gordon Allen. Editor.





Friendship through flowers is a universal aspect of all who admire plants and the environments in which they grow. The most cherished of these plants are moved and become a part of a created landscape out-of-doors or as an ornament/living design in our interiors. We thus treasure the plants from the wild landscape, learn how to propagate and grow them in a wide range of environments, and honor them with places of prominence in our living scapes.

The American Gardens are particularly indebted to plants whose origins can be traced to Asia. We estimate that 38 percent of the trees and 28 percent of the shrubs in our gardens are from Japan, Korea, and China. These plants thrive in our garden spaces. Along with the plants, have come many traditions of design, propagation, and culture. We do not expect that they will grow unattended. The plants of Asian origin can be clipped, trained, and formed to create landscapes in a miniature form that captures all the grandeur of the unbounded natural landscapes.

The U.S. National Arboretum

has been the beneficiary of the Nippon Bonsai Association of Japan, who presented 53 magnificent bonsai to the people of the U.S. as their gift for the Bicentennial. The collection included 3 bonsai from the Imperial Family and 3 from former Prime Ministers. The arboretum then constructed a Japanese Garden and Bonsai Pavilion to house the Collection and to expand the experiences of visitors.

The first phase of the expansion of the Bonsai Complex was funded by Ikebana International, Washington, D.C. Chapter No. 1 in honor of their founder-Ellen Gordon Allen. The garden was designed by Mr. Thomas Wirth, Sasaki Associates, Watertown, Massachusetts and was constructed by Mr. Osamu Shimizu, Shimizu Landscape Corporation, Glen Echo, Maryland. Mrs. Herbert O. Jones, President of the Washington, D.C. Chapter of Ikebana International, Mrs. Paul Godbey, Chairman of the Ellen Gordon Allen Memorial Committee, and members of the Washington Chapter dedicated their garden on June 9, 1983, in cooperation with the Friends of the U.S. National Arboretum.

The elegant and stately garden is attached by a series of steps to either the terrace of the Administration Building or Meadow Road. We have provided a ramp for the handicapped to enter the garden space and granite benches and ledges to allow visitors to rest and savor the garden. The largest plant in the space is a reclining Pinus thunbergii. (Drawing plant list) It's trunk has been wrapped with rope to add to the design and a brace has been added to support it. Planted in the space are other plants of Japanese origin such as Acer, Chamaecyparis, Deutzia, Ilex, Lagerstroemia, and Prunus. The Rhododendrons have selected not only for their spring flower color but also for their contrasting fall foliage colors. The planting also contains groups covers such as Ophiopogon and Ternstroemia, and perennials such as Aster Pespedeza and Lilium. The entire garden is flanked by 30 foot trees of Cryptomeria japonica. Most of the trees and shrubs in the garden show up again in the pavilion as a bonsai, with some of the plants as old as 350 years.




